- -- "One-shot" quantum information tasks, whose characterization in terms of (smooth) min- and max-entropies gives rise to a whole calculus of new quantities

- -- The finite blocklength approach and second order asymptotic expansions developed in classical information theory and recent advances in this area for quantum information theory
- -- Tools for analyzing channels with memory
- -- Strong converse theorems
- -- Classification and axiomatization of relative entropy measures
